**CONDITIONS OF SURETY BAIL BOND**

- 1. THE DEFENDANT MUST RETURN TO THIS OFFICE IMMEDIATELY UPON RELEASE FROM JAIL.**
- 2. THE DEFENDANT MUST APPEAR FOR ALL REQUIRED COURT DATES.**
- 3. THE DEFENDANT MUST CONTACT ALL-PRO BAIL BONDS AFTER EACH COURT AT THE FOLLOWING NUMBER: **1-888-845-2245****
- 4. IF THE DEFENDANT FAILS TO APPEAR IN COURT, HE/SHE MUST CONTACT ALL-PRO BAIL BONDS IMMEDIATELY TO AVOID SURRENDER BACK TO CUSTODY AND/OR ADDITIONAL FEES.**  
**\*Currently, the San Diego Superior Court charges a fee of no less than \$100.00 if the defendant fails to appear for any required appearance. However, if the court elects to waive the fee, ALL-PRO BAIL BONDS will not charge the client any additional fees.**
- 5. THE DEFENDANT AND/OR INDEMNITOR MUST CONTACT ALL-PRO BAIL BONDS IF ANY CHANGE OCCURS WITH RESPECT TO HIS/HER RESIDENCE, EMPLOYMENT OR PHONE NUMBER.**
- 6. THE INDEMNITOR AND DEFENDANT ARE RESPONSIBLE FOR ALL BAIL BONDS UNTIL THE BOND IS EXONERATED BY THE COURT.**  
**\*As a service to our customers, ALL-PRO BAIL BONDS will track the status of each active case and immediately retrieve all documentation regarding the exoneration.**
- 7. THE PREMIUM DUE FOR SAID BAIL BOND IS FULLY EARNED UPON THE DEFENDANTS RELEASE FROM JAIL. THE FACT THAT THE DEFENDANT MAY HAVE BEEN IMPROPERLY ARRESTED OR HIS/HER BAIL REDUCED OR HIS/HER CASE DISMISSED, SHALL NOT OBLIGATE THE RETURN OF ANY PORTION OF SAID PREMIUM. NO REFUNDS WILL BE ISSUED AFTER THE DEFENDANT HAS BEEN RELEASED FROM CUSTODY.**
